General Instructions for Partial Open Book Online Midterm/2nd Sessional Examination Session Fall 2015 for Graduate and Undergraduate Students of CIIT Virtual Campus

It is for the information of all concerned that Midterm/Second Sessional Examinations Fall 2015 are conducted online through CIIT Virtual Campus specialized examination software.

The examination will be taken as an open book/open source however online help, copy/paste facility and dictation/impersonation will be dealt as Unfair Mean (UFM).

Appearing students are directed to comply with the following instructions:-

- 1. The Midterm/Second Sessional Examination Fall 2015 will start from November 14, 2015, to November 22, 2015.
- 2. The Midterm/2nd Sessional Examination Fall 2015 will be a Partially Open Book Online Examination.
- 3. The duration of the each exam paper will be 60 Minutes
- 4. Student(s) registered as "Study From Home" can attempt their examinations from any place of their own choice.
- Student(s) registered as "Study Center Student" can attempt their paper from any place of their own choice as well as they can also attempt their examinations from their registered study center.
- 6. Student(s) shall plan their Date Sheet(s) as per given date(s) and time slot(s) according to their convenience.
- 7. To appear in the examination student(s) shall ensure the minimum required resources at their end, prescribed in the point NO. 8 below, failing to comply with, the student will be held responsible for any delay/cancelation in the commencement of examination.
- 8. Resources required for online examination at student's end are:
 - a) A stable internet connection.
 - b) A windows (Windows XP and above) workstation i.e. Laptop/Desktop.
 - c) An external Webcam installed, through which student shall be invigilated.

- d) A headphone and microphone installed, through which student shall be instructed by invigilation staff wherever required.
- e) Power backup in case of electricity failure during examination time slot
- 9. External Webcam is a mandatory requirement.
- 10. It is mandatory for the student to place their external webcam at such a distance that his/her face must remain visible along with the surroundings.
- 11. Internal webcam shall not be acceptable under any circumstances. The student will not be allowed to appear in examination or his/her examination will be dealt as canceled accordingly.
- 12. It is mandatory that the person appearing for online examination shall be the student himself/herself.
- 13. Any other person appearing in place of the student himself/herself during the examination will be dealt as an Unfair Mean (UFM) case.
- 14. Students are required to keep their Student ID Card(s) within reach. And shall show through webcam to the invigilator whenever asked.
- 15. The invigilator would not respond to any query related to the question paper.
- 16. The student(s) are advised to attempt the question as such; and may state some assumptions explicitly through email after examination.
